### Portfolio Objective

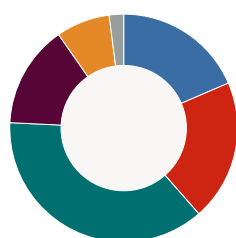

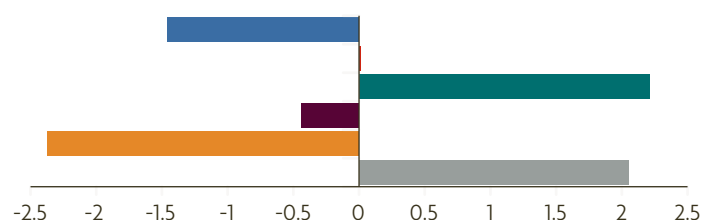

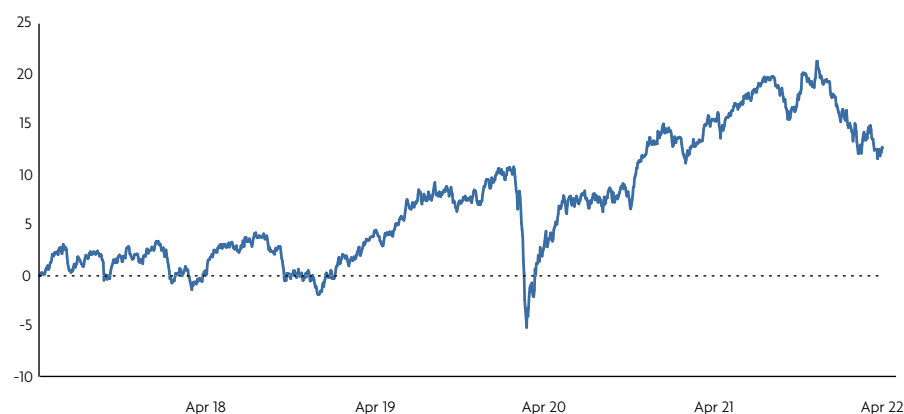
